AUTHORIZATION FOR RELEASE OF MEDICAL RECORD INFORMATION

I understand that once Weiss Hospital discloses my health information to the recipient, Weiss Hospital cannot guarantee that the recipient will not redisclose my health information to a third party. The third party may not be required to abide by this Authorization or applicable federal and Illinois law governing the use and disclosure of my health information.

I understand that Weiss Hospital may, directly or indirectly, receive remuneration from a third party in connection with the use or disclosure of my health information.

I understand that I may refuse to sign or may revoke (at any time) this Authorization for any reason and that such refusal or revocation will not affect the commencement, continuation or quality of my treatment at Weiss Hospital except, however, if my treatment at Weiss Hospital is for the sole purpose of creating health information for disclosure to the recipient identified in this Authorization, in which case Weiss Hospital may refuse to treat me if I do not sign this Authorization.

I understand that this Authorization will remain in effect until the term of this Authorization expires or I provide a written notice of revocation to Weiss Hospital Privacy Officer at the address listed below. The revocation will be effective immediately upon Weiss Hospital receipt of my written notice, except that the revocation will not have any effect on any action taken by Weiss Hospital in reliance on this Authorization before it received my written notice of revocation.
